Meeting Minutes Summarized.

Discussion about holding Wild Nights in 2021

Group Camp 2 is open in April. Oklahoma is currently a moderate risk area for Covid. Depending on the availability of the vaccine, we could require that attendees be vaccinated. However, current estimates for general vaccine availability range from March to May. Including a liability waiver for the virus suggested. Our current liability waiver should already cover it.

The campsite is also open later in the year. Heat starts becoming an issue once you get in to June. Fall could be an option.

Having a cap on attendance suggested. There are current no state mandated caps on gatherings. We would need a minimum of 150 attendees to break even for the year.

Donations to carry us through to next year, if we don't have the con, suggested. We currently have \$550 in the bank. We also have \$3286 in the paypal account, which comes from preregistration from 2020 that has been rolled over to the next time we are able to hold the convention. If we decide not to have the con this year, we would need about \$1100 over what is in the bank to cover our recurring costs. This could be covered with the money in paypal, but would leave us in a bad position for the next time we hold the convention, but we could make it work.

Hosting a digital event suggested. It would be difficult to replicate the feel of Wild Nights in a digital form, and what could be easily done digitally is not what we are best at. It could still be something to do to tide people over in April, if we end up simply delaying the convention, and an online charity auction to help out Safari's would not be a bad thing.
